## NEW MEMBERSHIP APPLICATION FOR YEAR

New applicants (and lapsed members who were not members in the past year) must be at least 18 years old, be an on-going annual or life NRA or other Second Amendment advocacy organization member, and submit the dues payment plus this fully completed/signed membership application to the above address or at the January annual membership meeting.

New applicants (and reapplying lapsed members) must also sign the Release and Waiver of Liability at the end of this application, and successfully complete a SSSC Range Safety Orientation.

The individual membership fee can be found on our website. Dues are applicable from January 1 thru December 31 each year.

An individual electronic gate code will be issued to each accepted individual member after completion of the SSSC Range Safety Orientation. Club benefits include: unsupervised access to the SSSC range facility and use of all range resources; access to Civilian Marksmanship Program (CMP); and hosting of shooting guests at the range.

## BASIC FIREARMS SAFETY RULES (to be followed at all times on and off the range)

1. Treat all guns as if they are always loaded
2. Never let the muzzle cover anything you are not willing to destroy
3. Keep your finger off the trigger until your sights are on target and you're ready to shoot
4. Be sure of your target and what is behind it

## SSSC RANGE SAFETY RULES

*Please initial next to each rule and sign the Membership Agreement and Release and Waiver of Liability.*

### WHEN MOVING GUNS TO AND FROM VEHICLES

- \_\_\_\_\_ Cased guns can be moved to/from the firing line shooting tables at any time (not behind the firing line), but **guns are not to be uncased (or touched) while people are downrange**
- \_\_\_\_\_ Uncased guns must not be moved to/from the shooting tables or long gun racks **while people are downrange**
- \_\_\_\_\_ Uncased guns must be holstered or carried with actions open and muzzles up

### CEASE FIRES

- \_\_\_\_\_ The pistol and rifle ranges are separate and distinct. Each range may have its own Range Safety Officer. Shooters on one range may shoot on that range, even if there is a cease fire on the other range. All other posted safety rules apply at both ranges.
- \_\_\_\_\_ Anyone may call an EMERGENCY CEASE FIRE if an unsafe condition is suspected. All guns must be holstered immediately or tabled until the unsafe condition is resolved.
- \_\_\_\_\_ During a GENERAL CEASE FIRE, all guns must be holstered, or unloaded and tabled/racked with actions open
- \_\_\_\_\_ **No guns shall be TOUCHED IN ANY WAY while anyone is downrange.**

GENERAL

- \_\_\_\_\_ During informal shooting activities with no designated Range Safety Officer, it is the **responsibility of every shooter to ensure all the safety rules are followed by all shooters**
- \_\_\_\_\_ SSSC members are responsible for the safety and conduct of their guests. (Members are limited to two active shooting guests at a time.)
- \_\_\_\_\_ Eye and ear protection is mandatory for everyone (including observers.)
- \_\_\_\_\_ Children must be under the constant control of a responsible adult
- \_\_\_\_\_ Unless changed by the designated Range Safety Officer, the firing line is parallel to the front of the shooting tables. Shooters may sit at the tables, or stand immediately behind or beside them.
- \_\_\_\_\_ 90 Degree Rule: The muzzle of the firearm must never break a 45 degree angle to the left or to the right from a line that is perpendicular to the firing line
- \_\_\_\_\_ The following are **STRICTLY PROHIBITED** on all range property:
  - Shooting from behind the firing line
  - Tracer or incendiary ammunition
  - Shooting at non-Club approved targets  
*(refer to web site FAQs for club approved targets)*
  - Alcohol or marijuana
  - Illegal drugs
  - Disorderly or reckless conduct

**MEMBERSHIP AGREEMENT**

I have read and understand the above Basic Firearms Safety Rules, and the SSSC Range Safety Rules, and agree to abide by these rules as a condition of my membership. I understand that these rules may be modified from time-to-time, and that those changes will be communicated to the membership in a timely manner. I also understand that **failure to obey the SSSC safety rules and club policies may result in termination of my membership and forfeiture of any paid dues.**

**NEW MEMBER NRA PLEDGE, RELEASE AND WAIVER OF LIABILITY**

In addition to the New Membership Application and related requirements, all new applicants are required to submit this completed NRA Pledge and Release and Waiver of Liability.

**NRA PLEDGE**

\_\_\_\_\_ (initial) I certify that I am a citizen of good repute of the United States of America; that I am not a member of any organization or group having as its purpose or one of its purposes the overthrow by force and violence of the Government of the United States or any of its political subdivisions; that I have never been convicted of a crime of violence; and that, if admitted to membership, I will fulfill the obligations of good sportsmanship and good citizenship.

**RELEASE AND WAIVER OF LIABILITY**

1. I acknowledge that shooting a firearm is an inherently dangerous activity. Consequently, while at the SSSC range I must and will follow the SSC safety rules and heed all commands from the designated range safety officer.
2. I warrant and represent that I am able to pass the CBI background check, that I am legally free to purchase and own firearms in the state of Colorado, and that I am under no type of restraining order which prevents my possession and/or use of firearms.
3. I hereby assume full responsibility for any and all risks, injuries and/or damages, known and unknown, or whatsoever kind or nature, which might incur as a result of shooting at the SSSC range.
4. I assume responsibility for the actions of any and all guests that I bring to the SSSC range.
5. In consideration of being permitted to participate at the SSSC range, I knowingly, voluntarily and expressly waive completely and without reservation, any and all claims I, or my Estate, my heirs, or any person claiming under me, may have against the SSSC, its officers, directors, employees, or representatives from any and all injuries or damages that I may sustain as a result of participating in shooting activities.
6. This release shall remain in full force and effect so long as I participate in activities at the SSSC range.
7. I have read, understand its contents, and fully agree with the above release and waiver of liability.
